POOL ACCESS: An activated access fob is required to open the interior gate leading to the pool during open swim hours. One complimentary fob will be issued to each household whose assessment account (including yard assessment) is paid current. An additional fob may be purchased at a cost of \$40. There is a limit of two (2) fobs to be issued per residence. All non-swimmers must be accompanied in the pool area by an adult who can swim. Replacement of damaged or lost fobs will also be \$40 per fob. These fobs will be used each year so hold on to them. Fobs will only be issued to an adult owner of the home and not to children or teens. The fobs will be deactivated should someone become delinquent on their account and at the end of the swim season and reactivated the following swim season for all owners in good standing.

Also note your association assessments must be paid in full with a zero balance before the order will be processed. Payment by check only to Harper's Preserve CA; no cash.
